Eliminating Poverty... Through Free Abortions?

California State Senator Nancy Skinner introduced SB 1142, which according to her webpage,

[W]ould establish a first-of-its-kind fund composed of state and philanthropic dollars that would significantly increase funding for abortion services for low-income Californians and for out-of-state residents who may come here for an abortion. The landmark bill would also create a comprehensive webpage for those seeking reproductive services in California, regardless of where they live.



Please allow me to translate that for you:

- ◆ *State and philanthropic dollars*: that's a euphemism for corporate grants combined with taxpayer money
- ◆ *Abortion services:* the surgical and/or chemical procedures which disrupt human lives in the zygotic, embryonic or fetal stage of development
- ◆ Low-income Californians and out of state-residents: basically anyone from anywhere with no money who wants to terminate the unborn

In other words: CA <u>wants to be a leader in the business of terminating the offspring of poor people</u>, whether they live there or not.

Governor Newsom also signed Senate Bill 245, named the *Abortion Accessibility Act*, which prohibits insurance companies from charging a co-pay or deductible for abortion procedures. They are marketing it as "ensuring equitable, affordable access." Sounds like a good thing... until you realize they are making money specifically terminating the offspring of poor people.

Florida Passes Anti-Grooming Bill

You might have heard it called the "Don't Say Gay" bill, but the Florida's Parental Rights in Education Act in reality just prohibits discussions about sex or gender identity between adults and children ages 4-8 (pre-K to 2nd grade) in school, and if those conversations *do take place*, that it can't be hidden from the child's parents.

Contrast that to LAUSD's position: "The parent's rights end at the schoolhouse door."



Basically, the money the "pregnant person" would pay for the procedure — which might cause them to rethink their decision — is now waived by the state. It's just a coincidence that whenever the government provides a service free-of-charge the number of people who will engage those services always increases.

So even if the "pregnant person" doesn't pay for the abortion, the federal government does. Billions of dollars a year get poured into the coffers of the organizations which then "donate" a lot to people to promote "Reproductive Care" -- another euphemism for ending the life of the unborn.

CA Minors can already abort without parental notification or consent, so any kid being sextrafficked who gets pregnant, can now abort in CA at taxpayer expense. All generously supplemented by philanthropic corporations who want to "eliminate poverty" the way Sweden "eliminated" Down's Syndrome.

COACH'S CORNER

We know many parents are struggling to jettison their controlling behavior in favor of putting the

outcome in their child's hands. Just like their children, Mom and Dad are learning a new skill, so that means a lack of proficiency in the beginning. It's completely understandable that some parents would fall back on old habits that can produce quick results.

But we would be remiss not to point out that the "just do what I say" method does absolutely nothing to develop and mature the adolescent brain. In fact, it uses up one of a limited number of opportunities your child will have to make that process happen.

Think about it this way: Let's say between puberty (about 13) and brain maturation (at 25), your child gets 100 chances a day to connect their behavior to their consequences (its significantly more, but stick with me for the purposes of this illustration). Let's say Mom or Dad use up about 20 of those chances telling your kid to brush his teeth, finish his homework, get off the phone, etc. Teachers use up another 50 a day working on material that (to your child's brain) will only seem important until the test. Then a few more opportunities are sacrificed just trying to fit in, or gain approval from his/her peers. And finally, at the end of the day, the hours playing video games or on social media depletes whatever chances are left to make connections, or strengthen the ones they have.

Now imagine that cycle is repeated 5 days a week, for 9 months of the year. Thousands of opportunities to develop sound reasoning abilities just **gone**. The maturation process is complete by 25, and the brain doesn't get additional surges of neural growth after puberty. There's no time extension available. Whatever you have at that point, is all there is.

Maybe thinking of it that way, coach, will help you stay motivated to make the most of those daily reasoning opportunities you're allotted!
